Payments to the *Unified Association (Denver Board of REALTORS® pending name change) are not deductible as charitable contributions; however, such payments may be deductible as ordinary business expenses in accordance with IRS rules and regulations. The \$53.37 of your year 2012 dues and \$25.00 for PSF voluntary dues are not deductible as a business expense because this portion is used for lobbying or the support of candidates at the local, state and/or national levels. A portion of your PSF voluntary fair share amount may be used to support federal candidates and will be charged against your limits under 2 U.S.C. 441a. No later than April 1, 2012, you may check ColoradoREALTORS.com to determine the portion. After CAR reaches its RPAC goal it may elect to retain your entire contribution for use in supporting state and local candidates and issues. You may contribute more or less than the suggested PSF amount. You may refuse to contribute the \$25.00 PSF voluntary fair share amount without reprisal and the National Association of REALTORS® or any of its state associations or local boards will not favor or disfavor any member because of the amount contributed.
